**AN ORDINANCE ESTABLISHING SALARIES FOR THE
BOROUGH OF WOODBINE FOR THE CALENDAR YEAR 2014**

BE IT ORDAINED by the Mayor and Council of the Borough of Woodbine in the County of Cape May as follows:

SECTION 1: This Ordinance shall be known as the salary Ordinance of the year 2014.
